Declaration on data protection and information security

1. Processing of personal data in connection with your use of our websites.

The protection of personal data is an important concern for Agro Grün GmbH. We collect, process, and use personal data only with your consent or order for the purposes agreed with you or if there is another legal basis in accordance with the DS-GVO; this in compliance with the applicable legal provisions on the protection of personal data and data security.

We only collect and process personal data that is required for the implementation and processing of our economic services or that you have voluntarily provided to us.

Personal data are individual details about personal or factual circumstances of an identified or identifiable natural person, for example name, address, email address, telephone number, date of birth, age, gender, identity card number, social security number, video recordings, photos, voice recordings of persons, as well as biometric data such as fingerprints, or even value judgments such as certificates.

1.1 Specific categories of data, purposes of processing and legal basis

In the course of your use of our websites, we process the following personal data:

- a. data entered voluntarily during registration, requests to contact us or in the context of participation in surveys.
- b. IP address, device type, browser type, previously visited websites or subpages or date and time of the respective visitor request, as well as information that is automatically sent to us by your web browser or terminal device (see also: cookies).

Your personal data is processed for the following purposes:

- a. the use of services.
- b. user authentication.
- c. the processing of requests and offers.
- d. the assertion of legal claims, or the defense against fraudulent and similar acts, including attacks on our IT infrastructure.

The processing of personal data is necessary to achieve the aforementioned purposes. We do not process the data provided to us for purposes other than those covered by the contractual agreement or by the explicit consent given by you or otherwise by a provision in accordance with the GDPR. Unless explicitly stated otherwise when collecting the personal data is not explicitly stated otherwise, the legal basis for data processing is:

- a. the performance and fulfillment of a contract with you (Article 6 (1) (b) of the DS-GVO);
- b. the fulfillment of legal obligations to which Agro Grün GmbH is subject (Article 6 (1) (c) of the DS-GVO); or
- c. the protection of legitimate interests of Agro Grün GmbH (Article 6 (1) (f) of the DS-GVO).

1.2 Transfer and disclosure of personal data to third parties

In order to fulfill your order, it may also be necessary to pass on your data to third parties. A transfer or disclosure of your personal data will only take place on the basis of the DS-GVO or on the basis of your prior express consent.

We hereby gladly inform you that in the course of our business activities, personal data may be transmitted to the following legal entities or authorities, as the case may be:

- a. Parent company, subsidiaries, if this is necessary in connection with the operation of our websites or the initiation, implementation, or settlement of the business relationship.
- b. Service providers of any kind, e.g., IT service providers, who process data in the context of your service provision.
- c. courts, arbitration tribunals, authorities, or legal advisors, if this is necessary to comply with applicable law, or to assert, exercise or defend legal claims.

Some of the above recipients are located or partially process your personal data in countries whose data protection laws provide a level of protection that is not equivalent to the level of protection provided by the country in which you are (resident) located. However, we only transfer your personal data to countries for which the EU Commission has decided that they have an adequate level of data protection. In addition, we take measures to ensure that all recipients have an appropriate and adequate level of data protection for which we conclude EU standard contractual clauses (2010/87/EC and/or 2004/915/EC).

Data published by you via our websites (e.g. in forums, testimonials, blog entries) may be accessible to other registered users of the respective website worldwide.

2. Data security, disclosure of data breaches

Your personal data is protected by appropriate organizational and technical precautions. These precautions relate in particular to protection against unauthorized, illegal or even accidental access, processing, loss, use and manipulation. However, despite always maintaining a reasonably high level of due diligence, it cannot be ruled out that information you disclose to us via the Internet may be viewed and used by unauthorized persons. Please note that we

therefore accept no liability for the disclosure of information due to errors in data transmission not caused by us or unauthorized access by third parties.

We make every effort to ensure that any data breaches are reported immediately to you or the relevant supervisory authority.

3. Storage of data

If no explicit storage period is specified when collecting personal data, your data will be deleted as soon as it is no longer required to fulfill the purpose for which it was stored, unless legal storage obligations (commercial, tax or civil law storage periods) prevent deletion.

4. Revocability of given consents

You have the right to revoke the consent given to us for the use/processing of your personal data at any time with effect for the future. The revocation does not affect the legality of the collection and processing carried out on the basis of the consent before the revocation. After such revocation, Agro Grün GmbH may only continue to process the personal data to the extent that the processing is linked to another legal basis in accordance with the DS-GVO.

5. Your rights as a data subject

According to applicable data protection law, you have, generally as a data subject, the right to information about your stored personal data, their origin and recipient and the purpose of data processing, as well as a right to rectification, data transfer, objection, restriction of processing and blocking or deletion of incorrect or unlawfully processed data, and the right to revoke any consent given for the use of your personal data.

If, in your opinion, the processing of your data by us violates applicable data protection law or infringes your data protection rights in any other way, you have the option of complaining to the supervisory authority. In Austria, the data protection authority (Vienna, district 8., Wickenburggasse 8-10) is responsible for this.

6. Use of server log files (cookies)

In order to optimize our website in terms of network performance and userfriendliness, our website automatically collects and stores information in so-called server log files (including Internet protocol address (IP address), browser and language setting, operating system, URL, date/time), which your browser automatically transmits to us. More information about the use of server log files by Agro Grün GmbH can be found in our cookie policy. There you can also see how you can object to the use of server log files and the processing of data collected via server log files.

7. Links to other websites
